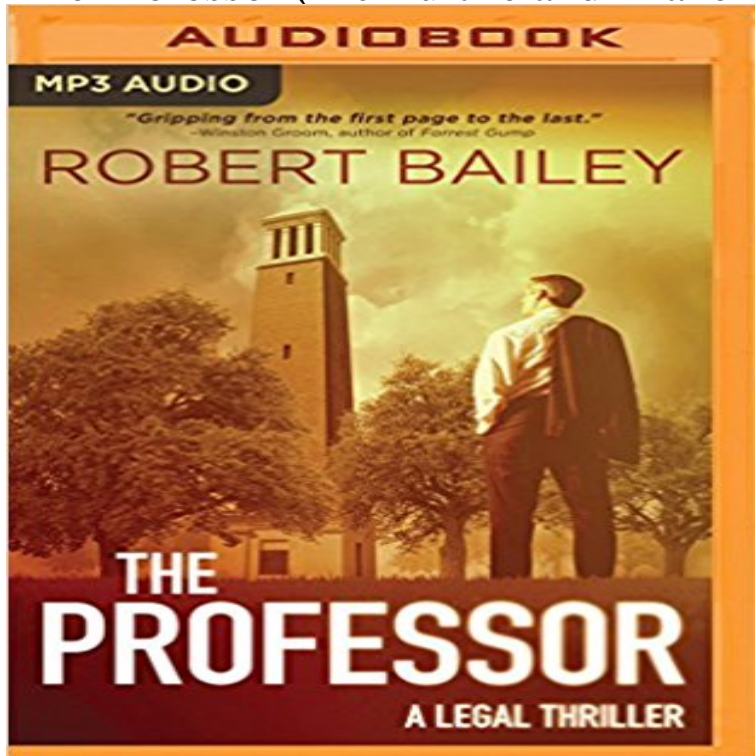


The Professor (McMurtrie and Drake Legal Thrillers)
